

4. Promoters hold total 7,98,78,676 (72.13%) Equity Shares in Wockhardt Limited. Pledge was earlier created on 1,75,56,000 Nos of Equity Shares (15.85%) held by Promoters in the Company. With the creation of Pledge on above mentioned 35,75,000 Nos. of Equity Shares (3.23%), the Pledged Shares now increased to 2,11,31,000 No. of Equity Shares (19.08%).
